FBI Background Check Request Form

Form for Field Experience (Not for Senior Student Teaching)

Field experience for education classes only requires a BCI check, while Student Teaching requires both a BCI and FBI check. Students should obtain the BCI and FBI checks the semester before they begin Student Teaching. About to begin Student Teaching in the near future? Please use other form.

What You Must Do:

- 1. Schedule a background check appointment by phone with the Clark Educational Service Center (ESC) (see contact information below).
- 2. Before your appointment, complete the "Request for Background via Electronic Fingerprinting" form (see next page).
- 3. Bring the following three items to your appointment:
 - a. Completed request form
 - b. Photo ID (e.g., driver's license)
 - c. \$30 in an accepted format

Cost: Each type of background check (BCI and FBI) costs \$30 each. ESC accepts the following forms of payment:

- EXACT cash (there is no cash for change)
- Credit or debit card (bank cards are NOT accepted)
- Personal check

During the background check, your fingerprint will be taken electronically on WebScan. The results will be sent to both the Wittenberg Education Department and the Ohio Department of Education.

Already have a <u>recent</u> background check from another organization (e.g. summer work at a daycare or camp)? Obtain a copy from the organization you sent your results to, and ask them to scan and email a copy of your results to you or directly to <u>educ-mail@wittenberg.edu</u>

If they no longer have your results on file, you may need to have another BCI check done.

- Why is this required?
- The majority of school districts in Ohio require that you have an Ohio BCI background check completed <u>before</u> going to observe/teach in the classroom. The Wittenberg Education Department has formal agreements with all local districts that students assigned to their schools will have these clearances on file. You will need to have this completed before being allowed to attend field experience.
- During <u>senior year</u>, to be licensed to teach in Ohio, the Ohio Dept. of Education (ODE) requires that you have both an Ohio BCI background check and a national FBI check completed.
- ODE must receive electronic results of your background checks from the Clark ESC & BCI before they will issue your license.
- Since BCI checks are valid for ONE year, and FBI checks are valid for FIVE years, your teaching license will not be issued unless both your BCI & FBI background checks are <u>still valid</u> at the time of application for your license.
