The student renter (“**LESSEE**”) does hereby agree to **lease** a Washer and Dryer (“**Equipment**”) from Open Sky Concepts, LLC (“**LESSOR**”), herein described in accordance with the terms and conditions set forth in this agreement:

1. **LOCATION:** The Equipment will be located and remain at the above Witten'Burbs Address for the term of the lease. Lessor will verify Lessee address with Wittenberg University Residence Life prior to installation, repair, or removal.
2. **RENT:** Full payment must accompany order. Rental rate listed above is for the entire Academic Year of August to May. Lessee understands that any Summer Term usage must be contracted separately and would result in separate charges. Relocation requests during the term of this agreement will result in a \$65 fee and require at least 72 hour advance notice.
3. **USE:** Lessee shall use the Equipment in a careful and proper manner and shall comply with all applicable laws and regulations. Lessee agrees to remove dryer lint prior to each use. Lessee agrees that the Equipment will be returned to lessor in the same appearance and condition as when received, ordinary wear and tear excepted. Lessee agrees to be liable for any damage to the Equipment resulting from vandalism, misuse, or negligence of the lessee.
4. **REPAIR & INSPECTION:** Lessee agrees to notify Lessor of any repair needs promptly. Lessor agrees to service the Equipment during normal business hours at lessor's expense. Lessor reserves the right to replace the units during the year, as needed. Lessor shall have the right to enter the premises where the Equipment is located for the purpose of repairing and /or inspecting the Equipment. Open Sky Concepts, LLC will, at its own discretion and expense, replace or repair the Equipment should they fail to operate properly, **EXCEPT if the Equipment is damaged through misuse, negligence, carelessness or irresponsible use** by the LESSEE.
5. **REFUND & CANCELLATION POLICY:** Within 30 days of installation, a complete refund less a \$75.00 processing/removal fee. **Cancellations beyond these time limits will receive no refund.**
6. **LIMITATION OF WARRANTIES:** Lessor has not made and does not make any representation, warranty, or covenant, express or implied, with respect to the condition of the Equipment, including express or implied warranty of merchantability, or its fitness for any particular purpose, use or operation. Lessor shall not be liable to lessee for any liability, loss, or damage caused directly or indirectly by the Equipment or the use thereof, by any inadequacy or defect, or by any incident in connection with the Equipment, including but not limited to consequential damages.
7. **END OF YEAR INSTRUCTIONS:** When leaving at the end of the year, Lessee will clean the washer and dryer units and remove dryer lint and leave the Equipment in place. Lessor will coordinate access with the Residence Life office in the summer to remove the Equipment.
