LASTING IMPACT

LONGTIME TIGER COACH & ADMINISTRATOR LINDA ARENA HONORED BY ALMA MATER

For Linda Arena, the 266 coaching wins at her alma mater, SUNY College of Brockport, and Wittenberg University are etched in her memory but perhaps faded a bit with time. The thrill of breaking ground for female student-athletes and sharing in their success years later never gets old, however.

Arena returned to SUNY College of Brockport in October 2016 to receive one of the most significant honors a coach or athlete can receive. Brockport named its new field hockey venue at Eunice Kennedy Shriver Stadium in honor of Arena, who was a standout in both field hockey and softball prior to her graduation in 1969 and later a coach at the university for more than a decade.

Arena said she knew she wanted to teach as soon as she began her collegiate career at Brockport. Her success as a player carried over to her work as a teacher and coach almost immediately after graduation. Years later, she would experience "the proudest moment of my career" when she was inducted into the Brockport College Hall of Fame.

"I truly believe that to teach is to touch a life forever," she said. "I believe that coaching is teaching. So playing took a back seat to finding the most effective way to bring smiles to the faces of my student-athletes."

As a coach at Brockport, Arena not only accommodated rosters numbering more than 60 student-athletes each year, but she led the Golden Eagles to the NCAA Division III Tournament three straight years. In 1981, Arena led the team to the national semifinals, marking the first time a Brockport women's team has advanced that far in NCAA play.

She went on to find similar success coaching at Wittenberg, where she also served as a professor in the department of health, fitness and sport and the university's director of women's athletics for more than a decade, in addition to amassing 194 wins while leading the Tiger field hockey program for 16 seasons. She retired from coaching in 1998 and from teaching in 2012, but not before making important inroads on behalf of female student-athletes at Wittenberg and beyond.

BACK IN THE BUCKEYE STATE

TAVER JOHNSON '94 RETURNS TO OHIO STATE TO COACH DEFENSIVE BACKS

It has been a long and winding road for former Tiger football All-American **Taver Johnson**, who recently arrived at his 11th coaching stop in 24 years. His continually sunny disposition indicates that he is no worse for the wear.

In fact, Johnson insists he is better off for the myriad of experiences. A coaching career that started at his alma mater in 1994 and 1995 includes stints at Millikin, Notre Dame, Miami (OH), the Cleveland Browns, back to Miami (OH), Ohio State, Arkansas, Purdue, Temple, and, finally, back to Ohio State.


He has coached every position on the defensive side of the ball and even special teams in the National Football League (NFL). His latest assignment is defensive backs coach for the Buckeyes, who won the Big Ten title and ranked in the top five nationally in 2017.

"I would never say I've seen it all," Johnson said. "It has been an amazing journey. I have met some unbelievable people along the way. This is part of what Wittenberg taught me, to cultivate and appreciate relationships."

A native of Cincinnati, Johnson is one of the most decorated players in the storied history of Wittenberg University football, earning first-team All-North Coast Athletic Conference (NCAC) and first-team All-America awards in 1992 and 1993, in addition to the Hank Critchfield Award as NCAC's top defensive player both years. He capped his career with NCAA Division III Defensive Player of the Year honors while leading the Tigers to a 9-1 overall record in 1993.

While working for Urban Meyer, who has won more than 90 percent of his games at Ohio State, and playing home games in famed Ohio Stadium in front of nearly 105,000 fans may seem like a world away from life at Wittenberg, Johnson said the goals and expectations for both programs are similar. An attitude and expectation of winning drives Johnson as he replaces Kerry Coombs, who developed five Buckeyes into first-round NFL picks in six years before accepting a position with the Tennessee Titans in January 2018.

"There are high expectations here, obviously," Johnson said. "This will be a heckuva challenge, but I'm looking forward to it. It's good to have high expectations. That is one of the things that attracted me to Wittenberg."





Jeff Brookings

Distinguished Teacher


The Wittenberg Motto alludes to knowledge, wisdom and faith as the sources of light the university hopes to pass on to others. Like others who have come before him, **Jeffrey Brookings** is a testament to how the warmth of a skilled and genuinely caring professor advances that cause.

Brookings reached a milestone when he received the Wittenberg Alumni Association's 2017 Award for Distinguished Teaching, an award "presented in recognition of superior classroom teaching and contributions to the academic life of the students and faculty of

Wittenberg University."

For Brookings, it is the career bookend to the student-bestowed Omicron Delta Kappa Award for Excellence in Teaching, which he received in his early years at Wittenberg.

Last May, the holder of the Paul Luther Keil Endowed Chair in Psychology reached another milestone when he finished his final class in Zimmerman Hall, taking home evidence of perhaps his most noteworthy accomplishments – those mentioned in notes from students.

After thanking him for his help with academic work, she mentions an item on the to-do list of so many who arrive on campus at 18: "Thank you for helping me attempt to figure out my life."

She then pens words every aspiring mentor dreams of reading: "I frequently tell people I want to be Dr. Brookings when I grow up."

Finally, there is the cherry on top: "You are truly like a second dad to a lot of us."

"I am not by any means the greatest classroom teacher," Brookings said over coffee at a Tim Horton's not far from campus. "There are people (at Wittenberg) who are so much more dynamic. It's really humbling how good they are. But teaching is more than what you do in a classroom, particularly at a school like Wittenberg. It's the relationships you develop with students."

He calls his 39-year career doing so "the dream job I could not have dreamed of."

A 1974 graduate of Louisiana Tech who earned his doctorate in 1980 from the University of Arkansas, Brookings found Wittenberg to be a "totally different environment" than the state schools he attended. He was nudged in the liberal arts direction by two professors "who saw something in me that I didn't see in myself."

When he came to Springfield on a visiting professorship in the fall of 1979, Brookings began seeing those same kinds of things in his students. Enamored of experimental psychology, personality psychology became Brookings' favorite course, one in which he came to favor the self-narrated approach "a way of studying personality from the inside out."

Although the stories people tell about themselves as not necessarily factually true, he said, "how people narrate their lives tells you about who they are and what's important to them." He also found the approach that so resonated with him "really engaged the students."

At the same time, Brookings continued to develop his teaching and professional interest in putting numbers to the narratives as a way of measuring elements of personality. "Psychometrics is really what I've done the most on, creating and evaluating tests of various types."

With one foot in the narrative realm and the other in the quantitative, he witnessed "the inherent tension" between the two camps in his and other

academic fields. Adherents to one side tend to caricaturize the others as either soulless number crunchers or spinners of tales that trail into fiction.

"The numbers by themselves won't tell you anything,"
Brookings said, but he sees obvious value in measuring theories to judge their merits.
That balanced attitude proved to be a strategic plus to his career:
"I found out that if you have quantitative skills, people will search you out."

The searchers included people working with issues of community concern, including teen suicide, eating disorders and domestic violence – issues on which he was more than happy to make contributions.

Among those with easiest access to Brookings' talents, though, have been his students.

Jean Pretz '97, Ph.D., professor of psychology at Elizabethtown College, Pa., said that just as he would later help her in her professional career, Brookings volunteered to design quantitative tools tailored to her student research.

He also provided more mundane help that brings to mind McNutt's use of the descriptor "dad."

"Jeff was so kind. I didn't have a car, and I didn't have any contact through the school system. He took me to a high school and tried to recruit people to be in the study."

Moreover, she said, "he felt comfortable having me in the driver's seat" in determining her area of research, even though it was not in the area of his own expertise. "He saw I could tackle (that) by myself." As important, he trusted her to do it.

"What I liked a lot and appreciated after the fact was that he gave me a lot of freedom, and I think he always has his students' interests in mind."

As it turns out, the freedom offered is reflective of Brookings the dad as well, something that emerges in a conversation with Sarah Connor, one of three Brookings children and a licensed professional counselor at the University of Alabama at Birmingham.

Although her early years with freedom to explore at Nightingale Montessori School in Springfield led to some bumpy spots when she transitioned to public schools, Connor said not only the freedom but the encouragement to explore a variety of subjects and think in a self-directed way were very much part of her home life.

"Even now, when I come back to visit, I bring a stack of books, and that's because, in the middle of the afternoon, my Dad and I sit down to read."

Brookings has freed colleagues to pursue their own ideas as well, using the same quantitative skills with which he has helped students and, in the process, contributing to Wittenberg's identity as a learning community. Co-authors of his publications include faculty Mary Jo Zembar, Jo Wilson and Clifford Brown, whose collaborations have encouraged Brookings to deepen his quantitative skills.

Spending every day of his career with such thinking, caring people has been another of Brookings' great pleasures, and the feeling has been mutual.

Brown, whose office has been next to Brookings for decades, says he has felt "doubly blessed" to have a friend like him during his now 40 years at Wittenberg.

Brown said the chance to share the tensions of the tenure process, the joy of professional conventions, family stories, and the moments of shared irony, cynicism and sarcasm with a friend to whom he can say anything has been "too good to be true."

Although not a statistical measure, it nonetheless seems to be an important measure of the warmth that Brookings and so many faculty like him have shared. Having that warmth, they have passed it on to others.

ENTREPRENEUR GINA SCHAEFER '93 LEADS IN HARDWARE INDUSTRY

Even though Gina Schaefer '93 worked in a hardware store as a teen, she never imagined that would be her future place of employment.

But after being laid off a few times in jobs within the tech industry and looking for quick supplies to spruce up her fixer-upper home, the political science major decided to tap her entrepreneurial side and open a much-needed hardware store in the metro area of Washington, D.C.

"In 1999, I moved to a neighborhood that had been destroyed by the riots in '68 and was finally, slowly showing signs of coming back. I was working in the tech industry and after getting laid off two or three times, I decided the neighborhood needed a hardware store and that I could open one," said Schaefer, originally from Louisville, Ohio. "I opened my first in 2003 and now own 12 with my husband, Marc Friedman."

Together they grew the company from one to 11 stores in a 12-year period. Logan Hardware, a member of the Ace Hardware Cooperative, is a multi-million-dollar small business that employs more than 240 people and is dedicated to maintaining a strong corporate culture. Her stores are located in Washington, D.C., Baltimore, Md. and Alexandria, Va.

During her time at Wittenberg, Schaefer was a member of Gamma Phi Beta and worked in the former Community Workshop as part of the community service program.

"Not only did I track/help students meet their service requirement, but I did a lot of community service myself including organizing some campus-wide events," Schaefer said. "I loved everything about my time at Wittenberg - my Spanish classes, the freedom of not living with my parents, making friends from all over the country (and world), working in the Community Workshop under the direction of Deborah Dillon, hiking in Yellow Springs, and being Greek. I could go on and on!"

The 47-year-old hasn't forgotten about community service either. She currently serves on the boards of House of Ruth, which provides services to victims of domestic violence, ILSR.org and the corporate board of CCA Global Partners. She also previously served on the board for Think Local First D.C., on the advisory board of Jubilee Jobs, and on the corporate board for Ace Hardware. In addition, she is a member of the Ace Center for Excellence.

LIFELONG CALLING

DENNIS EVELEIGH '69 LEADS IN LAW BY CINDY HOLBROOK

Ever since **Dennis Eveleigh '69** took a high school field trip to a Connecticut courthouse, he knew he wanted to be an attorney and spend his own career in a court room.

Now more than four decades later, Eveleigh can say his dream was achieved, having experienced an illustrious career in law, serving as a trial lawyer and as an associate justice with the Connecticut Supreme Court from which he recently retired.

After graduating from Wittenberg with a bachelor's degree in political science, Eveleigh, who grew up in Stamford, Conn., returned home where he earned his law degree from the University of Connecticut in 1972. In 1998, Eveleigh was named to the Connecticut Superior Court before joining the Connecticut Supreme Court in 2010. As a judge, he presided primarily over criminal, housing, civil and juvenile cases prior to his retirement in 2017.

"One decision, from when Eveleigh served on the complex litigation docket in Waterbury, seems to bear out Eveleigh's 'do the right thing' [mentality]," according to $Stamford\ Advocate$ reporter John Nickerson

"In a civil case brought by 70 municipalities against the state trash authority for overcharging them to make up for a bad loan, Eveleigh sided with the towns and cities. In 2007, Eveleigh agreed the municipalities were being unfairly penalized in excess tipping fees by the Connecticut Resources Recovery Authority to make up for losses incurred when it illegally loaned \$220 million to the Enron Corp. seven years earlier. Eveleigh said the agreement, originally characterized by the CRRA as an energy transaction, was nothing more than an illegal, unsecured loan and ordered CRRA to repay the municipalities \$35.8 million."

Prior to serving as a judge, Eveleigh was a trial counsel at the Bridgeport law firm of Goldstein & Peck from 1972-85 before starting his own practice. While in private practice, he served the state as an attorney trial referee, arbitrator and mediator, and also served as a special master in the federal court.

Eveleigh received the 2016 University of Connecticut Law Review award for excellence in legal scholarship and service to the legal community, as well as an honorary doctorate from Quinnipiac University. He and his wife Carol Wolven Eveleigh, former Bridgeport Superior Court judge, currently reside in Hamden, Conn.

As for his alma mater, "I loved the people at Wittenberg and the small class sizes it offered," said Eveleigh, who played baseball for four years and basketball for one year at Wittenberg. He was also president of the Beta Theta Pi fraternity and a member of Pi Sigma Alpha political science honorary fraternity. "It was a beautiful place to go to school."



A recovering alcoholic paddles 3,000 miles to show others in need that life is worth living.

Wittenberg has been a part of my life since before I was born. It's where my parents, Donn Gallatin '74 and B.J. McNeese Gallatin '76, met. My high school years were spent visiting my brother, Matt Gallatin '01, on campus. I always took for granted and joked about the meaning of Wittenberg's motto, "Having light, we pass it on to others." It wasn't until I found the "light" that I was able to understand.

After graduation, I set out to conquer the world like most graduates. However, my path was different than most Wittenberg alumni. My path was the Appalachian Trail, an idea planted in my mind after being pushed

to dig deeper on a paper written for Dr. Mac McClelland my freshman year. A once-in-a-lifetime trip. I definitely felt like I could do anything in life. Before finishing, I was already planning another trip, but by canoe. I figured it would take a year or two to save up the money. But two years turned into 10, and I still hadn't taken my trip.

When I realized that my life wasn't going in the direction that I wanted, I knew something had to change. The reason: I am an alcoholic and addict. I needed to take my life back, and when I was finally ready to do so, I knew where to go. I reached out to Dixie Brown '05, and another

classmate I knew had been through the same thing. I checked myself into a treatment center and held on. It wasn't easy, but it was the best decision I ever made. My life started getting better. I was learning to enjoy life again. I also realized I was given a second chance in life and that my long river trip dream could become a reality because I had gotten clean and sober. Having seen the "light," I decided to "pass it on to others."

I knew I wanted to start a nonprofit to raise money to help send people to treatment. At the same time, Dixie was starting The Seraph Fund. We teamed up and decided to make my trip the kick-off fundraiser.

My brother dropped me off June 1, kayak in hand, in downtown Columbus, and I took off. Down the small and scenic Scioto River to the larger Ohio River paddling through the locks and dodging coal barges. From the Ohio into the Mississippi River, the boats continued to get bigger as did the mosquitos of the Deep South in late July. After a little over two months of paddling, I paddled past ships from Hong Kong and pulled my boat over the levee wall of the 9th Ward in New Orleans in the middle of a downpour.

From there, I headed east weaving my way through the swamps of Louisiana and across the coast of Mississippi reaching Alabama. Crossing the Mobile Bay two miles off shore, a lightning storm came out of nowhere almost sinking my boat, but I made it to shore bruised and battered. I was able to limp into Gulf Shores, Ala., and recover, holed up in a hotel for three days. As hard as it was to get back in my kayak and continue on, I knew from past experience that you have to PRESS ON. Reaching Florida was a huge mental boost, but realizing that it was the middle of hurricane season quickly brought me back to reality. Two Words: Hurricane Irma.

While monitoring the storm for a few days, I quickly realized that I wanted nothing to do with it. I stored my boat at a marina, grabbed one of the last flights out and retreated to Ohio. The timing lined up perfectly to attend Wittenberg's Homecoming. With Florida recovering from storm damage, I headed east back on the Ohio River. With a borrowed boat, I set off to do 300 more miles paddling till 2 AM most nights. A few more weeks of sitting around waiting

to return to Florida proved the most difficult part of the trip. I can handle the weather, bugs, wild animals, but the sitting around doing nothing was torture. I finally returned to Florida and continued around the panhandle and headed South down the Gulf Coast, paddling between cruise ships, crossing the Tampa Bay South into Naples. Another seven days were then spent paddling through the Everglades in complete isolation, with the exception of some alligators and pythons. Two more days crossing the Florida Bay, through storms and being circled by sharks, I reached the Keys. A week later I pulled my boat out of the water for the final time at the southernmost point of the continental United States, with 3,000+ miles in the books.

This trip wasn't the route I had dreamed. It wasn't at the age I had dreamed it would be. It wasn't under the circumstances I had dreamed. It wasn't in the altered state of mind I had dreamed it would be. It was more than anything I could have dreamed it would be. It was fun and miserable, exciting and boring, relaxing and exhausting, hot and cold, wet and dry, muggy and buggy, beautiful sunsets and hurricanes that destroyed entire states, calm waters and seven-foot seas, but most of all it was worth it. The good days outweighed the bad. Something that I couldn't say two-and-half years ago about life when I was drinking and using.

I have learned that no matter what the news says, there are still good people in this country. People who will do anything for complete strangers. I have also learned that almost everyone has been affected by addiction either personally or through a loved one.


I am by no means a role model or spokesperson for recovery. I am just one of thousands who have been lucky enough to get out of addiction and into recovery. I'm by no way cured. It's an everyday battle, but it gets better. But for every person in recovery, there are 100's more struggling and dying thinking there's no hope.

Standing now with my feet in the water at the southernmost point of the United States, reflecting on the second chance I was given in life and to take a trip of a lifetime, pales in comparison to being able to help show others that recovery is possible.

Thank you to everyone who has contributed through donations and support. Reaching the 3,000-mile mark and Key West felt awesome, but hearing that we reached the goal of \$20,000 for The Seraph Fund is the most amazing feeling. Knowing that it can help others see that life is worth living to the fullest is the real accomplishment. Just because the paddling is done doesn't mean the work is over.
